

**SPRING TRAINING GETAWAY (“GIVE AWAY”)
OFFICIAL RULES**

ALL FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED. By entering the Spring Training Getaway Promotion (the “Promotion”), entrant agrees to be bound by these Official Rules. By entering this Promotion, winners agree to these rules and further agree to allow St. Lucie County Board of County Commissioners (the “County”) and St. Lucie Mets (the “Sponsors”) to use their names and photos for publicity purposes without compensation. The Promotion begins at 9:00 a.m. (E.S.T.) on February 1, 2010 and ends at 11:00 p.m. on Friday, February 26, 2010.

1. **ELIGIBILITY:** The Promotion is open only to individuals 18 years or older.
2. **HOW TO ENTER:** Go to www.visitstluciefla.com or www.metsinstlucie.com to enter. The County and Sponsors are not responsible for late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries and such entries will not be included in the Promotion. The Winner will be determined from all entries received. **All Entries will become public records and subject to public disclosure in accordance with provisions of Florida law.**
3. **WINNER SELECTION:** The Winners will be randomly selected.
4. **PRIZES:** 10 (ten) prizes valued at sixty (\$60.00) dollars will be awarded. The County and the Sponsors reserve the right to substitute a similar prize or prizes of equal or greater value in its sole discretion. All prizes will be awarded.
